- Work directly with children and young people in India?
- Want to reinforce your understanding of the principals of child protection?
- Want to gain an understanding of child sexual exploitation on and offline?
- Want to better understand the risk-taking behaviour of children?
- Want to know what you can do to help children stay safe on and offline?

NCA-CEOP's Safeguarding Children Training will equip those who work directly with children and young people to:

- ◇ Understand the context of child sexual exploitation on and offline in India
- ◇ Deliver a 45 minute lesson plan to children, young people and parents supported by NCA-CEOP educational resources
- ◇ Raise awareness to other appropriate colleagues
- ◇ Empower children and young people to stay safe

Delivered by NCA-CEOP's child protection and education specialists and local subject matter experts, this course is designed to be a **practical training session** giving you both the **background knowledge** and **access to resources** to build into your own educational work.

Who can attend?

Anyone working **directly** with children and young people, to include but not limited to teachers, staff of children's charities and NGOs, social workers and government education professionals.

Expectations of Delegates

Delegates are all expected to deliver the lesson plan taught out during training directly to children as well as run sessions to raise awareness of the issues with colleagues.
